We recently received results of LokSabha as well as some of the State assembly elections. NDA govt. Led by Mr Modi ji is once again returned in power with thumping majority. Let us congratulate the new govt and wish them five years of uninterrupted governance to help them to achieve "Sabka Saath, Sabka Vikas, Sabka Vishwas".

We received very good response for our last communications. Some of you have sent Donations, some wanted to know if there are any deserving poor Brahmin families who need ongoing support.

I take this opportunity to inform you that we have details of few Brahmin families who can do with help of say Rs. 15000/- per month to fulfil their basic needs. If any of you want to send donations for a month or few months on regular basis, do write to us and send your donations (eligible for I T Concession under Section 80G of Income Tax Act).

We have similarly a request received for a (Brahmin) child needing Medical assistance for Cochlear Implant surgery. The amount involved is Rs. 10 lakhs. Your generous support can help this child to hear and speak and lead a normal life after the surgery.

These are some of the appeals received by CF recently. We keep on getting these requests for medical support and financial support from time to time. We are currently able to support Rs. 25000/- per request (out of interest on funds collected so far). Our ability to support is a function of Donations received by us from all of you. We have similarly many requests to support overseas education expenses. We are unable to cater that for the time being for want of funds. We are supporting requests for Education expenses for higher education within India (once again up to Rs. 25000/-).

We request you to make it a point to visit our web site – your web site and give us your feedback on the quality and contents and any suggestions you may have for the same. We solicit your active involvement in updating this site with input from you about achievements of Chitpavans known to you, their good deeds in any walk of life.
